- 2 Risk Assessment Identifying analyzing and managing the risks that threaten the achievement of organizational objectives Z Library must assess risks related to copyright infringement data breaches system failures and legal challenges
- 3 Control Activities This component outlines the specific policies procedures and practices that mitigate identified risks For Z Library this includes implementing strong password policies encrypting data establishing rigorous filesharing protocols and enforcing clear copyright compliance measures
- 4 Information and Communication This component focuses on timely and accurate information flow within the organization Z Library needs effective systems to communicate policies procedures and risk assessments to all relevant stakeholders
