compiling this chart was deciding which sets of asian international arbitration rules to include in the chart in light of space and formatting limitations ultimately various factors were considered in deciding which sets of rules to include in the chart the china international economic and trade arbitration commission cieta hong kong international arbitration centre hkiac japan commercial arbitration association jcaa korean commercial arbitration board kcab and singapore international arbitration centre siac rules were included as leading sets of institutional asian international arbitration rules other asian institutional arbitration rules are not included simply for reasons of manageability and space the arbitration rules of the united nations commission on international trade law uncitral were included as the preeminent set of ad hoc international arbitration rules which are frequently used by parties in asia as well as by asian arbitration organizations such as the hkiac as the basis for their institutional arbitration rules the structure of this chart follows the structure of the second edition of our chart on international arbitration rules in part to facilitate the use of the two charts together like the second edition of the chart on international arbitration rules this chart contains an index of topics with page references to assist in locating subjects in the rules and the full texts of the sets of arbitration rules are included in an appendix for ease of reference
