THE PRIMARY OBJECTIVES OF AN AMC INCLUDE: - ENSURING UNINTERRUPTED SURVEILLANCE COVERAGE - MAXIMIZING SYSTEM UPTIME AND PERFORMANCE - PROVIDING TIMELY REPAIRS AND REPLACEMENTS - KEEPING THE SYSTEM COMPATIBLE WITH EVOLVING TECHNOLOGY - REDUCING UNEXPECTED EXPENSES THROUGH SCHEDULED MAINTENANCE

BY ESTABLISHING A CLEAR AMC, ORGANIZATIONS SAFEGUARD THEIR INVESTMENT IN CCTV INFRASTRUCTURE, PREVENT

  - SOFTWARE UPGRADES OUTSIDE THE SCOPE
7. PENALTIES AND LIABILITIES OUTLINES PENALTIES FOR NON-COMPLIANCE, DELAYED RESPONSE, OR FAILURE TO MAINTAIN AGREED STANDARDS.
8. TERMINATION CLAUSE CONDITIONS UNDER WHICH EITHER PARTY CAN TERMINATE THE CONTRACT, INCLUDING NOTICE PERIODS AND SETTLEMENT PROCEDURES.
9. CONFIDENTIALITY AND DATA SECURITY ENSURES THAT CLIENT DATA AND FOOTAGE ARE PROTECTED AND THAT THE SERVICE PROVIDER ADHERES TO PRIVACY STANDARDS.
