- 3 Use Relevant Business Concepts Demonstrate your understanding of key business theories and models relevant to the question Apply them correctly providing examples to illustrate your points Example If the question asks about Porters Five Forces accurately define each force and apply it to the specific business context presented in the case study
- 4 Use Accurate Business Terminology Employ precise terminology throughout your answers Using vague or incorrect terms weakens your response
- 5 Support Your Arguments with Evidence Dont just state opinions back them up with data examples or relevant case studies This showcases a deeper understanding of the topic
- 6 Review and Edit After completing the paper review your answers Check for grammatical errors logical flow and completeness

### D Analyzing Mark Schemes

After completing a past paper thoroughly review the mark scheme Understand not only the correct answers but also the reasoning behind the marking criteria This helps you identify areas where you lost marks and understand the expectations of the examiner Example The mark scheme might award marks for specific keywords application of theoretical frameworks and use of relevant examples
