specified Material Costs This section details the cost of all necessary materials including quantities unit prices and total cost Supporting documentation like invoices or quotes should be attached Equipment Costs This section covers the cost of equipment rental or purchase including transportation and operation Similar to materials supporting documentation is necessary Indirect Costs These represent overhead costs that are not directly attributable to specific tasks but are essential for project completion This includes administration supervision insurance and permits Contingency This critical element accounts for unforeseen events or cost overruns A percentagebased contingency is often applied reflecting the projects complexity and inherent risks Total Project Cost The sum of all cost elements including contingency Justification Each cost item should be clearly justified providing evidence to support the estimated cost This might include market prices historical data or expert opinions
