were mainly driven by diversification and the high liquidity in germany official statistics showed that diversified international portfolios performed better than national ones another point in the investigation is the development of the interest rate in sweden forecasts predict an increasing interest rate and so highly leveraged investors are likely to leave the market german funds instead can be 100 equity financed and so will win more market share in the next years
