TEXTBOOK OF PALLIATIVE MEDICINE PROVIDES AN ALTERNATIVE TRULY INTERNATIONAL APPROACH TO THIS RAPIDLY GROWING SPECIALTY THIS TEXTBOOK FILLS A NICHE WITH ITS EVIDENCE BASED MULTI PROFESSIONAL APPROACH AND GLOBAL PERSPECTIVE ENSURED BY THE INTERNATIONAL TEAM OF EDITORS AND CONTRIBUTING AUTHORS IN THE ABSENCE OF AN INTERNATIONAL CURRICULUM FOR THE STUDY OF PALLIATIVE MEDICINE THIS TEXTBOOK PROVIDES ESSENTIAL GUIDANCE FOR THOSE BOTH EMBARKING UPON A CAREER IN PALLIATIVE MEDICINE OR ALREADY ESTABLISHED IN THE FIELD AND THE STRUCTURE AND CONTENT HAVE BEEN CONSTRUCTED VERY MUCH WITH THIS IN MIND WITH AN EMPHASIS ON PROVIDING A SERVICE ANYWHERE IN THE WORLD INCLUDING THE IMPORTANT ISSUE OF PALLIATIVE CARE IN THE DEVELOPING NATIONS TEXTBOOK OF PALLIATIVE MEDICINE OFFERS A GENUINE ALTERNATIVE TO THE NARRATIVE APPROACH OF ITS COMPETITORS AND IS AN IDEAL COMPLEMENT TO THEM IT IS ESSENTIAL READING FOR ALL PALLIATIVE CARE PHYSICIANS IN TRAINING AND IN PRACTICE AS WELL AS PALLIATIVE CARE NURSES AND OTHER HEALTH PROFESSIONALS IN THE PALLIATIVE CARE TEAM

THE FOCUS OF THIS BOOK IS THE IDEA OF EQUALITY AS A MORAL POLITICAL AND JURISPRUDENTIAL CONCEPT THE AUTHOR IS MOTIVATED PRIMARILY BY A CONCERN TO BETTER UNDERSTAND CONUNDRUMS IN THE JUSTIFICATION INTERPRETATION AND APPLICATION OF DISCRIMINATION LAW NICHOLAS SMITH AIMS TO PROVIDE A CLEARER UNDERSTANDING OF THE NATURE OF THE VALUE THAT THE LAW IS TRYING TO UPHOLD EQUALITY HE REJECTS THE NOTION THAT THE CONCEPT OF EQUALITY IS VACUOUS AND DEFENDS THE IDEA AS THE PROPER RANGE OF MORAL CONCERN AFTER DISCUSSING THE GENERAL CHARACTERISTICS OF THE DENIAL OF EQUALITY AND SOME TYPES OF DISCRIMINATION SMITH CONSIDERS PROMINENT VIEWS ON THE POINT OF EQUALITY LAW HE ARGUES THAT HUMAN RIGHTS LAWYERS SHOULD STEP BACK FROM THE BUSINESS OF TRYING TO STEER COURTS TOWARDS VAGUE EQUALITY GOALS INFORMED BY CONCEPTIONS OF EQUALITY THAT ARE EITHER EMPTY OR EVEN MORE ABSTRACT THAN THE NOTION OF EQUALITY ITSELF IF THEY DO SMITH THINKS THAT THE MEANING OF EQUALITY WILL BE APPARENT THOUGH ABSTRACT AND OUR DIFFICULTIES WILL BE SHOWN TO BE IN THE FIRST INSTANCE MORAL ONES THESE MORAL ISSUES WILL REQUIRE MORE RIGOROUS ATTENTION BEFORE WE CAN DRAFT DISCRIMINATION LAW WHICH GIVES CLEAR EFFECT TO A WIDELY LEGITIMATE UNDERSTANDING OF WHAT IT MEANS TO UPHOLD AND PROMOTE EQUALITY THIS BOOK WILL BE A VALUABLE RESOURCE FOR STUDENTS AND RESEARCHERS WORKING IN THE AREAS OF LEGAL PHILOSOPHY POLITICAL THEORY PUBLIC LAW AND HUMAN RIGHTS LAW

THE BOOK WRITTEN WITH A RICH TEACHING AND RESEARCH EXPERIENCE OF THE AUTHOR EMPHASISES THE CRITICAL EVALUATION OF CONTEMPORARY HUMAN RIGHTS LAW AND PRACTICE WITH SPECIAL REFERENCE TO INDIA IT ALSO EVALUATES THE ONGOING DISCOURSE ON VARIOUS ISSUES RELATING TO LIFE LIBERTY EQUALITY AND HUMAN DIGNITY AND THEIR REFLECTIONS IN INTERNATIONAL HUMAN RIGHTS LAW REFERRING THE STATE PRACTICES THROUGH CONSTITUTIONAL GUARANTEES JUDICIAL DECISIONS AS WELL AS THROUGH ENACTING APPROPRIATE LEGISLATIONS THIS LUCID AND COMPREHENSIVE BOOK IS LOGICALLY ORGANISED INTO NINE CHAPTERS BEGINNING WITH THE THEORETICAL FOUNDATIONS OF HUMAN RIGHTS LAW REFERRING TO ORIGIN DEVELOPMENT AND THEORIES OF HUMAN RIGHTS AT PRELIMINARY LEVEL THE BOOK PROCEEDS TO INTERNATIONAL BILL OF HUMAN RIGHTS DEMONSTRATING VARIOUS FACETS OF CIVIL AND POLITICAL RIGHTS AS WELL AS ECONOMIC SOCIAL AND CULTURAL RIGHTS IT FURTHER DISCUSSES THE IMPORTANCE OF HUMAN RIGHTS LAW IN PROTECTION AGAINST INHUMAN WRONGS AND EXAMINES A LARGE NUMBER OF DEBATES CONCERNING HUMAN RIGHT TO DEVELOPMENT AND PROTECTION OF ENVIRONMENT THEN IT MOVES ON TO EXPLORE VARIOUS ISSUES RELATING TO HUMAN RIGHTS IN INDIAN CONSTITUTIONAL LAW THE LATTER PART OF THE BOOK EMPHASISES ON THE PROTECTION OF RIGHTS OF WOMEN AND CHILDREN WHICH HAS BEEN THE FOCAL POINT OF ALL HUMAN RIGHTS DISCUSSIONS IT ALSO DEALS WITH THE SCOPE AND AMBIT OF THE RIGHTS OF INDIGENOUS PEOPLES AND MINORITIES INCLUDING THEIR PROTECTION AT THE END THE BOOK EXAMINES THE UTILITY AND JUSTIFICATIONS OF HUMAN RIGHTS LAW IN PROTECTING THE RIGHTS OF PEOPLE WITH DISABILITIES DIVYANG THOUGH THE BOOK IS PRIMARILY DESIGNED FOR LLB BA LLB AND LLM AND COURSES ON HUMAN RIGHTS IT WILL BE EQUALLY BENEFICIAL FOR THE RESEARCHERS ACADEMICIANS JURISTS LAWYERS JUDGES AS WELL AS MEMBERS OF CIVIL SOCIETY

THERE IS A GROWING SENSE THAT MANY LIBERAL STATES ARE IN THE MIDST OF A SHIFT IN LEGAL AND POLITICAL NORMS A SHIFT THAT IS HAPPENING SLOWLY AND FOR A VARIETY OF SECURITY RELATED REASONS THE INTERNET AND TECH BOOMS THAT ARE PAVING THE WAY FOR NEW FORMS OF ELECTRONIC SURVEILLANCE PREDATED THE 9 11 ATTACKS BY SEVERAL YEARS WHILE THE POLICE S VAST USE OF SECRET INFORMANTS AND DECEPTIVE OPERATIONS BEGAN WELL BEFORE THAT ON THE OTHER HAND THE RECENT UPTICK IN REACTIONARY MOVEMENTS MOVEMENTS IN WHICH THE RULE OF LAW SEEMS EXPENDABLE BEGAN MANY YEARS AFTER 9 11 AND CONTINUES TO THIS DAY IN THE RETRIEVAL OF LIBERALISM IN POLICING LUKE WILLIAM HUNT PROVIDES AN ACCOUNT OF HOW POLICING IN LIBERAL SOCIETIES HAS BECOME ILLIBERAL IN LIGHT OF BOTH INTERNAL AND EXTERNAL THREATS TO SECURITY HUNT PROVIDES AN EXAMINATION OF THE MORAL LIMITS ON MODERN POLICE PRACTICES THAT FLOW FROM THE BASIC LEGAL AND PHILOSOPHICAL TENETS OF THE LIBERAL TRADITION ARGUING THAT POLICING IN LIBERAL STATES IS CONSTRAINED BY A LIBERAL CONCEPTION OF PERSONS COUPLED WITH PARTICULAR PRINCIPLES OF THE RULE OF LAW PART I LAYS OUT THE BOOK S THEORETICAL FOUNDATION BEGINNING WITH AN OVERVIEW OF THE POLICE S LAW ENFORCEMENT ROLE IN THE LIBERAL POLITY AND A METHODOLOGY FOR EVALUATING THAT ROLE PART II ADDRESSES APPLICATIONS OF THAT THEORY INCLUDING THE POLICE S USE OF INFORMANTS DECEPTIVE OPERATIONS AND SURVEILLANCE HUNT CONCLUDES BY EMPHASIZING HOW THE LIBERAL CONCEPTION OF PERSONS AND THE RULE OF LAW CONSTRAIN POLICING FROM MULTIPLE FOUNDATIONAL STANCES MAKING THE KEY POINT THAT POLICING IN LIBERAL SOCIETIES HAS BECOME ILLIBERAL IN LIGHT OF ITS RESPONSE TO BOTH INTERNAL AND EXTERNAL THREATS TO SECURITY OVERALL THIS BOOK PROVIDES AN ACCOUNT OF WHAT IT MIGHT MEAN TO RETRIEVE POLICING THAT IS CONSISTENT WITH THE BASIC TENETS OF LIBERALISM AND THE LIMITS IMPOSED BY THOSE TENETS

NATIONS AROUND THE WORLD ARE EXPERIENCING A SPECTACULAR INCREASE IN LONGEVITY SOCIETY AS A WHOLE IS BEING CHALLENGED BY ISSUES ARISING FROM THIS REVOLUTION IN LONGEVITY ALTHOUGH THE SPECTER OF THE LONELINESS AND EXISTENTIAL SUFFERING OF OLDER CITIZENS IS SUCH THAT SOME PEOPLE UNDER THE AGE OF 65 FIND IT DIFFICULT TO CONCEIVE OF A LONG TERM FUTURE PERSONS OVER 85 HAVE PROVEN THAT AGING DOES NOT NECESSARILY PRECLUDE A HEALTHY AND PRODUCTIVE LIFE EXTRAORDINARY PROGRESS IN BOTH CURATIVE AND PREVENTIVE MEDICINE JUSTIFIES OPTIMISM ABOUT THE QUALITY OF LIFE AND STATE OF WELL BEING THAT CAN BE ENJOYED EVEN IN GREAT OLD AGE WE SHOULD LOOK TO PROFESSIONALS IN DIVERSE FIELDS TO DEVELOP CREATIVE SOLUTIONS TO THE INEVITABLE ISSUES THAT WILL ARISE WITH AGING GOVERNMENTS MUST PREPARE FOR THE FUTURE HEALTH OF THEIR CITIZENS BY MAKING LONG TERM INVESTMENTS TO EDUCATE ALL SECTORS OF SOCIETY IN THE VALUE OF GOOD NUTRITION EXERCISE AND LIFESTYLES THAT ENHANCE WELL BEING THROUGHOUT LIFE ALSO GOVERNMENTS SHOULD REALIZE THAT THE MAIN CAUSE OF HEALTH CARE EXPENDITURE IS SERIOUS ILLNESS WHICH OCCURS IN PERSONS OF ALL AGES AND NOT PREDOMINANTLY IN OLDER PEOPLE EARLY DETECTION CAN HELP SAVE LIVES AS WELL HEALTH AND LONGEVITY OF LIFE WILL ULTIMATELY END AS A POLITICAL ISSUE WHAT IS NEEDED IS LONG TERM GOVERNMENT INVESTMENTS NECESSARY FOR A VIABLE HEALTH POLICY THE QUESTION ARISES WILL WORLD LEADERS BE ABLE TO COMMIT TO SUCH A POLICY TWO MAJOR SOCIOECONOMIC PHENOMENA MAY HAVE A REGULATING EFFECT ON THIS ISSUE THE FIRST IS THE EMERGENCE OF PRESSURE GROUPS THAT HAVE COME INTO BEING IN RESPONSE TO A PARTICULAR HEALTH ISSUE SUCH AS AIDS THE SECOND IS THE EMERGENCE OF ETHICS COMMITTEES IN DEVELOPED NATIONS THAT DEAL SOLELY WITH HEALTH ISSUES

WHAT IF POLITICAL RHETORIC IS UNAVOIDABLE AN IRREDUCIBLE PART OF POLITICS ITSELF IN CONTRAST TO THE FAMILIAR DENUNCIATIONS OF POLITICAL HORSE TRADING GRANDSTANDING AND CORPORATE MANIPULATION FROM THOSE LAMENTING THE CRISIS IN LIBERAL DEMOCRACY THIS BOOK ARGUES THAT THE POLITICS OF POLITICS USUALLY

ASSOCIATED WITH RHETORIC AND SOPHISTRY IS LIKE IT OR NOT PART OF POLITICS FROM THE START DENUNCIATIONS OF THE SORRY STATE OF CURRENT POLITICS DRAW ON A DOGMATISM AND MORALISM THAT SHARE AN ESSENTIALLY METAPHYSICAL AND PLATONIC GROUND FAILURE TO DECONSTRUCT THAT GROUND GENERATES A PHILOSOPHICALLY AND POLITICALLY DEBILITATING SELF-RIGHTEOUSNESS THAT THIS BOOK ATTEMPTS TO UNDERSTAND AND UNDERMINE AFTER A DETAILED ANALYSIS OF FOUCAULT'S INFLUENTIAL LATE CONCEPT OF PARRHESIA WHICH IS SHOWN TO BE BOTH PHILOSOPHICALLY AND POLITICALLY INSUFFICIENT CLOSE READINGS OF HEIDEGGER KIERKEGAARD AND DERRIDA TRACE COMPLEX RELATIONS BETWEEN SOPHISTRY RHETORIC AND PHILOSOPHY TRUTH AND UNTRUTH DECISION MADNESS AND STUPIDITY IN AN EXPLORATION OF THE POSSIBILITY OF DEVELOPING AN AFFIRMATIVE THINKING OF POLITICS THAT IS NOT MORTGAGED TO THE METAPHYSICS OF PRESENCE IT IS SUGGESTED THAT HEIDEGGER'S COMPLEX ACCOUNTS OF TRUTH AND DECISION MUST INDEED BE READ IN CLOSE CONJUNCTION WITH HIS NOTORIOUS NAZI COMMITMENTS BUT NEVERTHELESS CONTAIN ESSENTIAL INSIGHTS THAT MANY STRIDENT RESPONSES TO THOSE COMMITMENTS IGNORE OR REPRESS THOSE INSIGHTS ARE HERE DEVELOPED VIA AN AMBITIOUS ACCOUNT OF DERRIDA'S OFTEN MISUNDERSTOOD INTERRUPTION OF TELEOLOGY INTO A DESTRUCTIVE RETRIEVAL OF THE CONCEPT OF DIGNITY THIS LUCID AND OFTEN WITTY ACCOUNT OF A CRUCIAL SET OF DEVELOPMENTS IN TWENTIETH CENTURY THOUGHT PREPARES THE WAY FOR A MORE GENERAL RE-READING OF THE POSSIBILITIES OF POLITICAL PHILOSOPHY THAT WILL BE UNDERTAKEN IN VOLUME 2 OF THIS WORK UNDER THE SIGN OF AN ESSENTIAL SCATTER THAT DEFINES THE POLITICAL AS SUCH

ARGUES THAT LGBTQ CATHOLICS AND THEIR ALLIES HAVE BEEN STRUGGLING FOR RECOGNITION AND PASTORAL CARE IN THE U.S. CATHOLIC CHURCH SINCE THE 1940S USING A VARIETY OF STRATEGIES TO INTEGRATE THEIR FAITH AND SEXUALITY AND NAVIGATE THE INSTITUTIONAL CHURCH
