intervals and tools for surveillance and screening are recommended based on risk levels abdominal ultrasonography combined with serum alpha fetoprotein tests routine surveillance is recommended every 6 months for high risk plc routine surveillance every 3 months and enhanced ct mri examinations every 6 12 months is recommended for those with extremely high risk of plc the surveillance interval can be extended to one year or longer for those with low or intermediate risk because the annual incidence of low risk plc is relatively low the cost effectiveness of these recommendations remains to be evaluated
