versions of emotivism is another yet despite the fact that russell held on to some form of emotivism for most of his professional life and despite the fact that the theory is present in some of his best known books it was virtually ignored until the late 1990s michael k potter s book brings an important new dimension to our understanding of russell s life his activism and his contribution to moral philosophy
