- BE HONEST AND ACCURATE: ALWAYS PROVIDE TRUTHFUL INFORMATION SUPPORTED BY FACTS OR DOCUMENTATION.
- BE SPECIFIC: USE CONCRETE EXAMPLES TO ILLUSTRATE THE APPLICANT'S NEEDS AND CHALLENGES.
- KEEP IT PROFESSIONAL: USE FORMAL LANGUAGE AND A RESPECTFUL TONE.

WHILE THERE IS NO STRICT FORMAT, IT SHOULD BE CLEAR, PROFESSIONAL, AND INCLUDE AN INTRODUCTORY PARAGRAPH, BODY WITH SUPPORTING DETAILS, AND A CLOSING STATEMENT. USING A FORMAL LETTER FORMAT WITH DATE, SALUTATION, AND SIGNATURE IS RECOMMENDED. CAN A SUPPORT LETTER BE HANDWRITTEN OR DOES IT NEED TO BE TYPED? IT IS GENERALLY RECOMMENDED THAT THE SUPPORT LETTER BE TYPED FOR CLARITY AND PROFESSIONALISM, BUT HANDWRITTEN LETTERS MAY BE ACCEPTED IF LEGIBLE AND PROPERLY FORMATTED. HOW LONG SHOULD A SAMPLE SUPPORT LETTER FOR MEDICAID BE? A SUPPORT LETTER SHOULD TYPICALLY BE CONCISE, RANGING FROM ONE TO TWO PAGES, INCLUDING ALL RELEVANT INFORMATION WITHOUT UNNECESSARY DETAILS.
