the extent to which humanitarian intervention has become a legitimate practice in post cold war international society is the subject of this book it maps the changing legitimacy of humanitarian intervention by comparing the international response to cases of humanitarian intervention in the cold war and post cold war periods crucially the book examines how far international society has recognised humanitarian intervention as a legitimate exception to the rules of sovereignty and non intervention and non use of force while there are studies of each case of intervention in east pakistan cambodia uganda iraq somalia rwanda bosnia and kosovo there is no single work that examines them comprehensively in a comparative framework each chapter tells a story of intervention that weaves together a study of motives justifications and outcomes the legitimacy of humanitarian intervention is contested by the pluralist and solidarist wings of the english school and the book charts the stamp of these conceptions on state practice solidarism lacks a full blown theory of humanitarian intervention and the book supplies one this theory is employed to assess the humanitarian qualifications of the cases of intervention analysed in the book and this normative assessment is then compared to the moral practices of states a key focus is to examine how

far humanitarian intervention as a legitimate practice is present in the diplomatic dialogue of states in exploring how far there has been a change of norm in the society of states in the 1990s the book defends the broad based constructivist claim that state actions will be constrained if they cannot be legitimated and that new norms enable new practices but do not determine these the book concludes by considering how far contemporary practices of humanitarian intervention support a new solidarism and how far this resolves the traditional conflict between order and justice in international society

this edited volume critically examines the responsibility to protect r2p as a guiding norm in international politics after nato s intervention in libya against the backdrop of civil wars in syria and yemen and because of the cynical support for r2p by states such as saudi arabia this norm is the subject of heavy criticism it seems that the r2p is just political rhetoric an instrument exploited by the powerful states hence the r2p is being challenged at the same time however institutional settings normative discourses and contestation practices are making it more robust new understandings of responsibility and the politics of protection are creating new normative spaces patterns of legitimacy and norm entrepreneurs thereby reinforcing the r2p

this book's goals are to discuss the r2p's roots, institutional framework and evolution to reveal its shortcomings and pitfalls and to explore how it is exploited by certain states. Further, it elaborates on the r2p's strength as a norm. Accordingly, the contributions presented here discuss various ways in which the r2p is being challenged or confirmed or both at once, as the authors demonstrate. These developments concern not only diplomatic communication and political practices within international institutions but also normative discourses. Furthermore, the book includes chapters that reevaluate the r2p from a normative standpoint, e.g., by proposing cosmopolitan standards as a guide for states' external behavior. Other contributors reassess the historical evidence from UN negotiations on the r2p principle and the productive or restrictive role of institutions, discussing new issues relating to the r2p such as global and regional power shifts or foreign policy as well as the phenomenon of authoritarian interventionism under the r2p umbrella. This book will appeal to all its scholars and students interested in humanitarianism, norms and power, by analyzing the status quo of the r2p, it enriches and broadens the debate on what the r2p currently is and what it ought to be.

Internally displaced persons (IDPs) are persons who have been forced to leave their places of residence as a result of armed conflict, violence, human rights violations or natural or human-made disasters but who have not crossed an international border. There are about 55 million IDPs in the world today, outnumbering refugees by roughly 2:1. Although IDPs and refugees have similar wants, needs and fears, IDPs have traditionally been seen as a domestic issue and the international legal and institutional framework of IDP protection is still in its relative infancy. This book explores to what extent the protection of IDPs complements or conflicts with international refugee law. Three questions form the core of the book's analysis: what is the legal and normative relationship between IDPs and refugees; to what extent is an individual's real risk of internal displacement in their country of origin relevant to the qualification and cessation of refugee status; and to what extent is the availability of IDP protection measures an alternative to asylum. It argues that the IDP protection framework does not, as a matter of law, undermine refugee protection. The availability of protection within a country of origin cannot be a substitute for granting refugee status unless it constitutes effective protection from persecution and there is no real risk of refoulement. The book concludes by identifying current and future challenges in the relationship between IDPs and refugees, illustrating the overall impact and importance of the findings of the research and setting out questions for future research.

Somalia, Haiti, Bosnia and Kosovo all are examples where humanitarian intervention has been called into action. This timely and important new volume explores the legal and moral issues which emerge when a state uses military force in order to protect innocent people from violence perpetrated or permitted by the government of that state.
