in 1975 mr rabhan traveled to iran as a businessman where he successfully farmed produced infant formula and manufactured children's clothing one day in 1980 when he was driving to one of his factories in damgitam he was arrested accused of being a spy and imprisoned without formal charges his first year was spent largely in solitary confinement after seven and half years the iranian officials finally filed charges against mr rabhan in 1988 and he was given a specific sentence of two years for being a spy in august 1990 the court said the charge was a mistake and the american david rabhan walked away from evin prison in tehran iran with an incredible story in his head and with two suitcases stuffed with more than three hundred sketches of prisoners who like himself were incarcerated for alleged political crimes against the khomeini regime together the incredible stories and the unbelievable illustrations appearing in this book express the triumph of human dignity and spirit david rabhan is one of the most interesting people i know the examples of prison art give an insight into his extraordinary character former president jimmy carter

this book discusses the popularity of temporary and child marriages in iran and afghanistan and explores their historical background and the reasons why they still persist today further it offers readers insights into the emotional and psychological violence that the women who have been subjected to these practices experience the respective contributions address the persistence of these traditions their ramifications for the wellbeing of women and the development of societies and human relations taken together they offer an excellent academic tool for students academics and researchers studying the anthropology and sociology of kinship and family in the middle east

during recent years attempts have been made to move beyond the eurocentric perspective that characterized the social sciences especially anthropology for over 150 years a debate on the anthropology of anthropology was needed one that would consider other forms of knowledge modalities of writing and political and intellectual practices this volume undertakes that challenge it is the result of discussions held at the first organized encounter between iranian american and european anthropologists since the iranian revolution of 1979 it is considered an important first step in overcoming the dichotomy between peripheral anthropologies versus central anthropologies the contributors examine from a critical perspective the historical cultural and political field in which anthropological research emerged in iran at the beginning of the twentieth century and in which it continues to develop today

previously understudied and misunderstood period matthew p canepa elucidates the many ruptures and renovations that produced a new royal culture that deeply influenced not only early islam but also the wider persianate world of the il khans safavids timurids ottomans and mughals

middle east turkey s support for the opposition in syria iran s only true state ally in the middle east is one example iraq has also become a field of growing competition between turkey and iran iran s nuclear program has been a source of strain and divergence in u s turkish relations however the differences between the united states and turkey regarding iran s nuclear program are largely over tactics not strategic goals turkey s main fear is that iran s acquisition of nuclear arms could lead to a nuclear arms race in the middle east this in turn could increase pressure on the turkish government to consider developing its own nuclear weapon capability u s and turkish interests have become more convergent since the onset of the syrian crisis however while u s and turkish interests in the middle east closely overlap they are not identical thus the united states should not expect turkey to follow its policy toward iran unconditionally turkey has enforced united nations sanctions against iran but given ankara s close energy ties to tehran may be reluctant to undertake the harshest measures against iran

iran s continued retention of discriminatory laws stands in stark contrast to the advances iranian women have made in other spheres since the revolution in 1979 leila alikarami here aims to determine the extent to which the actions of women s rights activists have led to a significant change in their legal status she argues that while iranian women have not yet obtained legal equality the gender bias of the iranian legal system has been successfully challenged and has lost its legitimacy more pertinently the social context has become more prepared to accommodate legal rights for women highlighting the key challenges that proponents of gender equality face in the muslim context alikarami attempts to ascertain the causes of iran s failure to ratify the cedaw and questions whether and to what extent interpretations of islamic principles prevent iran from doing so applying feminist legal theory to contemporary iran alikarami s approach re evaluates the underlying principles that have shaped the struggle for equal rights between the sexes

since the revolution in 1979 the islamic republic of iran has permitted very few western scholars to conduct research in the country foreign travellers and media persons have limited access and much iranian scholarship tends to focus on the realms of politics and government here julia huang provides a remarkable account of local tribal iranian life offering a rare glimpse into the daily rhythms and social richness beyond the capital city of tehran the qashqa i are a confederation of nomadic tribes of which the qermezi red ones are one migrating semiannually between winter pastures near the persian gulf and summer pastures southwest of the city of isfahan huang has visited and traveled with the qermezi for extended periods across fourteen years drawing on her experiences participation and observation she offers an intimate window onto their life she focuses on a small group of women spanning four generations who are part of a large extended family and describes their ways of life their activities and interactions and their distinctive sociocultural and ecological setting like other nomadic peoples around the world the qashqa i increasingly face pressures that threaten their livelihoods lifestyles and culture huang shows us how women negotiate compromises between customary tribal values and external influences and sketches their efforts to resist the

influences of an islamizing modernizing and centralizing government with shadows and resonances that rebound across the stories of these women huang is able to present multiple perspectives on events and contentious issues for instance the politicized issue of women s state mandated modest dress huang also explains how the turkic speaking qashqa i relate to the wider iranian society and the islamic republic of iran adapting to a rapidly changing world while retaining tribal values and a distinctive ethnolinguistic identity as one of iran s national minorities in describing life at the local level in iran huang depicts a community largely beyond the scope and reach of foreign travellers and the western media with rich ethnographic description and analysis intimate portraits of the private lives and spaces of women and children and diverse perspectives this engagingly written account documents a disappearing way of life tribeswomen of iran is essential reading for all those interested in iran the middle east anthropology nomadism and gender

we live in an age of global migration the number of immigrants worldwide is large and growing at the same time public and political reactions against immigrants have grown in the us the uk canada and other traditional and non traditional receiving nations in response to this trend this book assembles an interdisciplinary group of scholars to better understand two dimensions of contemporary immigration policy a growing enforcement and restriction regime in receiving nations and the subsequent effects on sending nations it begins with three background chapters on immigration politics and policies in the united states europe and mexico this is followed by eleven chapters about specific receiving and sending nations four for the united states three for europe and four for the sending nations of mexico turkey peru and poland this selection of cases and the multidisciplinary approach provides a unique perspective that supplements more standard case studies and disciplinary research by discussing a greater range of nations and topics the global consequences of increased deportations stronger border security greater travel restrictions stagnant economies and the loss of remittances this volume fills a significant gap in the current body of literature as such this book is of interest to immigration policy scholars and students of all levels as well as individuals in think tanks advocacy communities the media and governments

the iranian nuclear saga has been of grave concern to the international community namely the west and israel since news broke in 2002 that tehran clandestinely operated two nuclear facilities in natanz and arak the islamic republic of iran claims that it is exercising its inalienable right under the nuclear non proliferation treaty however the west and israel distrust iran s motives and believe that tehran is seeking to develop nuclear weapons iran s nuclear program and bellicose negotiating strategy has

triggered concern among the west and israel prompting the question as to whether their cause for concern is warranted this concern is examined in deterrence in an era of iranian nuclear proliferation by assessing the theories of nuclear deterrence and applying them in a 2008 2009 iranian context to determine whether nuclear deterrence failures would arise should iran acquire nuclear weaponry

examining the rapid transition in iran from a modernizing westernizing secularizing monarchy 1941 79 to a hard line conservative clergy run islamic republic 1979 this book focuses on the ways this process has impacted the qashqa i a rural nomadic tribally organized turkish speaking ethnic minority of a million and a half people who are dispersed across the southern zagros mountains analysing the relationship between the tribal polity and each of the two regimes the book goes on to explain the resilience of the people s tribal organizations kinship networks and politicized ethnolinguistic identities to demonstrate how these structures and ideologies offered the qashqa i a way to confront the pressures emanating from the two central governments existing scholarly works on politics in iran rarely consider iranian society outside the capital of tehran and beyond the reach of the details of national politics local level studies on iran accounts of the ways people actually lived are now rare especially after the revolution based on long term anthropological research nomads in postrevolutionary iran provides a unique insight into how national level issues relate to the local level and will be of interest to scholars and researchers in anthropology iranian studies and middle eastern studies

following the 1979 islamic revolution there was a dramatic reversal of women s rights and the state revived many premodern social conventions through modern means and institutions customs such as the enforced veiling of women easy divorce for men child marriage and polygamy were robustly reintroduced and those who did not conform to societal strictures were severely punished at the same time new social and economic programs benefited the urban and rural poor especially women which had a direct impact on gender relations and the institution of marriage edited by janet afary and jesilyn faust this interdisciplinary volume responds to the growing interest and need for literature on gender marriage and family relations in the islamic context the book examines how the institution of marriage transformed in iran paying close attention to the country's culture and politics part one examines changes in urban marriages to new forms of cohabitation in part two contributors such as soraya tremayne explore the way technology and social media has impacted and altered the institution of family part three turns its eye to look at marital changes in the rural and tribal sectors of society through the works of anthropologists including erika friedl and mary

hegland based on the work of both new and established scholars the book provides an up to date study of an important and intensely politicized subject

carried out by the government of the shah between 1962 and 1971 the iranian land reform was one of the most ambitious such undertakings in modern middle eastern history yet beneath apparent statistical success the actual accomplishments of the program in terms of positive benefits for the peasantry were negligible later the resulting widespread discontent of thousands of iranian villagers would contribute to the shah s downfall in the first major study of the effects of this widely publicized program eric hooglund s analysis demonstrates that the primary motives behind the land reform were political attempting to supplant the near absolute authority of the landlord class over the countryside the central government hoped to extend its own authority throughout rural iran while the pahlavi government accomplished this goal its failure to implement effective structural reform proved to be a long term liability hooglund who conducted field research in rural iran throughout the 1970s and who witnessed the unfolding of the revolution from a small village provides a careful description of the development of the land reform and of its effects on the main groups involved landlords peasants local officials merchants and brokers he shows how the continuing poverty in the countryside forced the migration of thousands of peasants to the cities resulting in serious shortages of agricultural workers and an oversupply of unskilled urban labor when the shah s government was faced with mass opposition in the cities in 1978 not only did a disillusioned rural population fail to support the regime but thousands of villagers participated in the protests that hastened the collapse of the monarchy
