TO AVOID THIS, COMPANIES MUST ENSURE THEIR ESG INITIATIVES ARE GENUINE, TRANSPARENTLY REPORTED, AND INDEPENDENTLY VERIFIED. FOCUSING ON MEASURABLE IMPACT AND AVOIDING VAGUE CLAIMS IS CRUCIAL.

4 HOW DOES STAKEHOLDER CAPITALISM DIFFER FROM SHAREHOLDER PRIMACY? SHAREHOLDER PRIMACY PRIORITIZES MAXIMIZING SHAREHOLDER VALUE ABOVE ALL ELSE. STAKEHOLDER CAPITALISM RECOGNIZES THAT A COMPANY'S SUCCESS DEPENDS ON A BROADER RANGE OF STAKEHOLDERS, INCLUDING EMPLOYEES, CUSTOMERS, SUPPLIERS, COMMUNITIES, AND THE ENVIRONMENT.
