TODAY THAN AT ANY TIME IN THE RECENT PAST MAGAZINES AND TELEVISION PROGRAMS PROFILE WOMEN BANK
EXECUTIVES SURGEONS AND CORPORATE LAWYERS BUT THE VAST MAJORITY OF WOMEN STILL WORK IN
RELATIVELY LOW PAYING JOBS WOMEN WORK MORE HOURS PER WEEK IN THE HOUSE AND OUTSIDE THAN EVER
BEFORE AND A PAYING JOB HAS BECOME A NECESSITY FOR WOMEN IN MOST HOUSEHOLDS WHAT WENT WRONG
IN THIS PROVOCATIVE BOOK MARY ANN MASON ARGUES THAT THE WOMEN'S MOVEMENT SHARES SOME OF THE

TO BE AVAILABLE IN CASE OF A CHILD CARE PROBLEM WITH NEARLY 50 PERCENT OF ALL MARRIAGES NOW ENDING IN DIVORCE AND WITH A GROWING TREND INSPIRED BY THE EQUAL RIGHTS MOVEMENT TOWARD NO FAULT DIVORCE AND LOW OR NO ALIMONY SETTLEMENTS DIVORCED MOTHERS FREQUENTLY FIND THEMSELVES ECONOMICALLY DEVASTATED MARY ANN MASON ARGUES THAT THE SOLUTION TO THIS PREDICAMENT IS TO DRAW UP A NEW WOMEN S RIGHTS AGENDA THAT WILL BENEFIT ALL WORKING WOMEN ESPECIALLY THOSE WITH CHILDREN THE EQUAL RIGHTS STRATEGY WAS IMPORTANT IN OPENING THE DOOR FOR THE HIGHLY PUBLICIZED SUPER ACHIEVERS BUT IT IS NOW TIME SHE SAYS TO IMPROVE THE LIVES OF THE MAJORITY OF AMERICA S WORKING WOMEN THIS BOOK WILL BE OF INTEREST TO READERS INTERESTED IN GENDER STUDIES AND PARTICULARLY ISSUES OF EQUALITY AND FEMINISM MARY ANN MASON IS A PROFESSOR OF LAW AND SOCIAL WELFARE AT THE UNIVERSITY OF CALIFORNIA BERKELEY IN ADDITION TO HER LAW DEGREE MASON HOLDS A PH D IN AMERICAN SOCIAL HISTORY

THE EQUALITY OF FLESH TRACES A NEW GENEALOGY OF EQUALITY BEFORE ITS FORMALIZATION UNDER LIBERALISM WHILE MODERN IDEAS OF EQUALITY ARE DEFINED THROUGH AN INNER HUMAN NATURE BRENT DAWSON ARGUES THAT THE SIXTEENTH AND SEVENTEENTH CENTURIES CONCEPTUALIZED EQUALITY AS AN AMBIVALENT AND PROFOUNDLY BODILY CONDITION EVERYONE WAS MADE FROM THE SAME LOWLY MATTER AND AS A RESULT SHARED THE SAME SET OF VULNERABILITIES NEEDS AND PASSIONS RESPONDING TO THE POLITICAL UPHEAVALS OF COLONIALISM AND THE INTELLECTUAL TURMOIL OF NEW NATURAL PHILOSOPHIES LEADING FIGURES OF THE ENGLISH RENAISSANCE INCLUDING EDMUND SPENSER AND WILLIAM SHAKESPEARE ANXIOUSLY IMAGINED THAT BODILY COMMONALITY MIGHT UNDERMINE DIFFERENCES OF RELIGION RACE AND CLASS AS THE PERIOD PROGRESSED LATER AUTHORS DEVELOPED THE REVOLUTIONARY POSSIBILITIES OF BODILY EQUALITY EVEN AS NEW IDEAS OF FIXED RACIAL INEQUALITY EMERGED SOME LIKE THE UTOPIAN RADICAL GERRARD WINSTANLEY AND THE REPUBLICAN POET JOHN MILTON CHALLENGED POLITICAL ABSOLUTISM THROUGH THE IDEA OF HUMANS AS BASE EMBODIED CREATURES OTHERS LIKE THE HETERODOX PHILOSOPHER MARGARET CAVENDISH THE FRENCH THEOLOGIAN ISAAC LA PEYR[?] RE AND THE LIBERTINE CYRANO DE BERGERAC OFFERED LIMITED YET IMPORTANT INTERROGATIONS OF RACIAL PARADIGMS THIS MOMENT DAWSON SHOWS WOULD PASS AS BODILY EQUALITY WAS MARGINALIZED IN THE LIBERAL THEORIES OF JOHN LOCKE AND THOMAS HOBBS IN ITS PLACE DURING THE ENLIGHTENMENT PSEUDOSCIENTIFIC RACISM WOULD COME TO ANCHOR INEQUALITY IN THE BODY CONTENDING WITH THE LASTING IMPLICATIONS OF MATERIAL EQUALITY FOR MODERNITY THE EQUALITY OF FLESH SHOWS HOW INCREASINGLY VEHEMENT NOTIONS OF RACIAL DIFFERENCE ECLIPSED A NASCENT SENSE OF HUMAN COMMONALITY ROOTED IN THE BASIC STUFF OF LIFE

THIS STUDY EXPLORES AND CRITIQUES LAW AND LAW MAKING IN THE NASCENT CONSTITUTIONAL DEMOCRACY IN THE NEW SOUTH AFRICA WITH A FOCUS ON THE COMPLEX ROLES OF THE EXECUTIVE PARLIAMENT POLITICAL PARTIES THE MEDIA AND CIVIL SOCIETY THE CAPACITY AND POTENTIAL IN THE JUDICIARY AND THE LEGAL PROFESSION IN PROMOTING AND PROTECTING VALUES AND RIGHTS OF EQUALITY AND NON DISCRIMINATION IS EXAMINED SUBSTANTIVE EQUALITY AND NON DISCRIMINATION LAW IN THEORY AND IN PRACTICE IS CONSIDERED CRITICALLY FROM A BROAD HISTORICAL AND SOCIAL CONTEXT THAT HIGHLIGHTS AREAS OF RACE GENDER DISABILITY HARASSMENT AND HATE SPEECH SOCIO ECONOMIC RIGHTS AND LEGAL SERVICES INTERNATIONAL HUMAN RIGHTS LAW AND COMPARATIVE LAW ASPECTS ARE SKILLFULLY INTERWOVEN IN THIS PIONEERING SCHOLARLY WORK

THE RISE OF THE NEW JUDICIAL FEDERALISM MOVEMENT IN THE 1970S MARKED A SEA CHANGE IN THE HISTORY OF STATE CONSTITUTIONAL LAW BY SHIFTING THE FOCUS OF POWER AWAY FROM THE CENTRAL GOVERNMENT

IN WAYS THAT HAD NOT OCCURRED SINCE THE EQUAL PROTECTION CLAUSE WAS ENACTED IN 1868 WITH NEW JUDICIAL FEDERALISM MANY STATES REDISCOVERED THAT THEY WERE EMPOWERED TO ENACT THEIR OWN CONSTITUTIONS AND TO INTERPRET THEM AS THEY SAW FIT WHICH ENABLED STATES TO RECOGNIZE CIVIL RIGHTS AND LIBERTIES BEYOND THOSE RECOGNIZED UNDER THE FEDERAL CONSTITUTION EQUALITY AND LIBERTY IN THE GOLDEN AGE OF STATE CONSTITUTIONAL LAW CLOSELY EXAMINES THE EVOLUTION OF THE RIGHTS OF LIBERTY AND EQUALITY UNDER STATE CONSTITUTIONS FROM BOTH A HISTORICAL AND JURISPRUDENTIAL PERSPECTIVE IN IT PROFESSOR JEFFREY M SHAMAN EXPLAINS THAT AS NEW JUDICIAL FEDERALISM GAINED GROUND STATE CONSTITUTIONAL LAW BECAME AN IMPORTANT SOURCE FOR THE PROTECTION OF INDIVIDUAL RIGHTS AND LIBERTIES STATES HAVE SINCE EXPANDED THE RIGHT OF THE CITIZEN WELL BEYOND THE LIMITS OF FEDERAL LAW BY STRIKING DOWN LAWS THAT LED TO DE FACTO SEGREGATION IN PUBLIC SCHOOLS DISCRIMINATED AGAINST WOMEN OR ALLOCATED PUBLIC BENEFITS INEQUITABLY STATE COURTS WERE THE FIRST TO RECOGNIZE A RIGHT OF INTIMATE ASSOCIATION SPURRING THE U S SUPREME COURT TO FOLLOW SUIT EQUALITY AND LIBERTY IN THE GOLDEN AGE OF STATE CONSTITUTIONAL LAW IS ESSENTIAL READING FOR ANYONE INTERESTED IN THIS MANIFESTATION OF LAW THAT HAS DEVELOPED BEYOND THE PURVIEW OF NATIONAL ATTENTION AND IN THE RESULTING EVOLUTION OF POWER IN U S CONSTITUTIONAL LAW

THE PRINCIPLES OF EQUALITY AND NON DISCRIMINATION LIE AT THE HEART OF INTERNATIONAL HUMAN RIGHTS LAW THEY ARE THE ONLY HUMAN RIGHTS EXPLICITLY INCLUDED IN THE UN CHARTER AND THEY APPEAR AT THE BEGINNING OF VIRTUALLY EVERY MAJOR HUMAN RIGHTS INSTRUMENT THIS VOLUME CONTAINS SELECTED WORKS BY LEADING AUTHORS ON THE SUBJECT OF EQUALITY AND NON DISCRIMINATION UNDER INTERNATIONAL LAW THE SELECTIONS ARE GROUPED INTO FOUR SECTIONS THE FIRST PRESENTS ESSAYS THAT EXPLORE THEORETICAL CONCEPTS OF EQUALITY AND NON DISCRIMINATION THE NEXT ADDRESSES THE DEVELOPMENT OF INTERNATIONAL LEGAL STANDARDS ON THE SUBJECT THE THIRD PRESENTS ARTICLES ANALYZING HOW THOSE STANDARDS HAVE BEEN INTERPRETED AND APPLIED BY UN AND REGIONAL HUMAN RIGHTS BODIES AND THE LAST CONTAINS WORKS ON WHAT MEASURES BESIDES LEGAL ACTION STATES ARE TO TAKE TO IN ORDER TO ACHIEVE EQUALITY AND NON DISCRIMINATION

POLICIES PLAY A PIVOTAL ROLE IN SHAPING LITERACY OUTCOMES BY SETTING EDUCATIONAL STANDARDS ALLOCATING RESOURCES AND DEFINING INSTRUCTIONAL METHODOLOGIES THAT INFLUENCE HOW LITERACY IS TAUGHT AND ASSESSED ACROSS DIFFERENT EDUCATIONAL CONTEXTS HOWEVER THE DYNAMIC NATURE OF SOCIETY NECESSITATES THE CONSTANT REVISITATION OF THESE POLICIES TO ADAPT TO EVOLVING TECHNOLOGICAL ADVANCEMENTS CULTURAL SHIFTS AND EMERGING PEDAGOGICAL RESEARCH WITHOUT SUCH CONTINUAL REASSESSMENT POLICIES RISK BECOMING OUTDATED AND INEFFECTIVE IN ADDRESSING CONTEMPORARY LITERACY CHALLENGES FURTHERMORE INTEGRATING THE PERSPECTIVES OF VARIOUS POLICY

ACTORS CAN LEAD TO MORE COMPREHENSIVE AND EFFECTIVE LITERACY POLICIES BY EMBRACING THIS INCLUSIVE APPROACH TO POLICY DEVELOPMENT AND REVISION EDUCATION SYSTEMS CAN ENHANCE THEIR ABILITY TO SUPPORT DIVERSE LEARNING NEEDS AND IMPROVE OVERALL LITERACY SKILLS FOR ALL STUDENTS LITERACY POLICIES FOR EQUITY AND INCLUSION INVESTIGATES THE GROWING DEBATES AND PRESSING ISSUES SURROUNDING THE RE CREATION IMPLEMENTATION AND EVALUATION OF VARIOUS LITERACY POLICIES IT EXPLORES THE PERSPECTIVES AND EXPERIENCES OF DIFFERENT STAKEHOLDERS REGARDING EXISTING LITERACY POLICIES EFFECTIVE POLICIES FOR ADDRESSING OR MITIGATING LITERACY DISPARITIES IN DIFFERENT ENVIRONMENTS AND HOW NEW OR REVISED LITERACY POLICIES CAN BE EFFECTIVELY INTEGRATED INTO EDUCATIONAL SYSTEMS TO PRODUCE TANGIBLE IMPROVEMENTS COVERING TOPICS SUCH AS GENDER SENSITIVITY DISCIPLINE LITERACY AND 19TH CENTURY ENGLISH LITERATURE THIS BOOK IS AN EXCELLENT RESOURCE FOR EDUCATORS SCHOOL ADMINISTRATORS POLICYMAKERS SOCIAL JUSTICE ADVOCATES PROFESSIONALS RESEARCHERS SCHOLARS ACADEMICIANS AND MORE

THIS REPORT MAPS STRATEGIES GOVERNANCE TOOLS INSTITUTIONAL SETTINGS AND INNOVATIVE APPROACHES USED BY GOVERNMENTS ACROSS THE OECD TO DRIVE AND SUPPORT SOCIETY WIDE GENDER EQUALITY GOALS IT COVERS ALL STATE INSTITUTIONS INCLUDING LEGISLATURES AND JUDICIARIES AND DISCUSSES THE CHALLENGES

THE EC DIRECTIVE ESTABLISHING A GENERAL FRAMEWORK FOR EQUAL TREATMENT IN EMPLOYMENT AND OCCUPATION COVERS A NUMBER OF GROUNDS OF DISCRIMINATION INCLUDING AGE THE EU S POPULATION IS AGEING BUT THERE IS MUCH EVIDENCE THAT AGE DISCRIMINATION IS WIDESPREAD THE DIRECTIVE IS A REACTION TO THAT AND THE CONSEQUENT DESIRE TO ENCOURAGE GREATER PARTICIPATION IN THE LABOUR MARKET BY OLDER WORKERS THIS IS THE FIRST TIME THAT AGE DISCRIMINATION HAS BEEN MADE UNLAWFUL BY THE EU AND AS A RESULT THERE ARE NOW LAWS IN EVERY MEMBER STATE MAKING SUCH DISCRIMINATION UNLAWFUL THE DIRECTIVE AND MUCH OF THE NATIONAL LEGISLATION HOWEVER TREATS AGE DISCRIMINATION DIFFERENTLY TO THE OTHER GROUNDS FOR UNLAWFUL DISCRIMINATION IT IS THE ONLY AREA WHICH PERMITS DIRECT DISCRIMINATION AGE DISCRIMINATION GENERALLY MAY STILL BE OBJECTIVELY JUSTIFIED BY A LEGITIMATE AIM IF THE MEANS OF ACHIEVING THAT AIM ARE APPROPRIATE AND NECESSARY SUCH AIMS INCLUDE LEGITIMATE EMPLOYMENT POLICY LABOUR MARKET AND VOCATIONAL TRAINING OBJECTIVES THIS INSIGHTFUL BOOK WRITTEN BY NATIONAL EXPERTS IN EIGHT MEMBER STATES AND AT THE EU LEVEL CONSIDERS THE WAYS IN WHICH THE DIRECTIVE HAS BEEN IMPLEMENTED IN SOME OF THE MEMBER STATES AND THE EXTENT TO WHICH THEY HAVE TAKEN ADVANTAGE OF THE EXCEPTIONS THAT ARE INHERENT IN THE DIRECTIVE PARTICULAR ISSUES THAT ARE COVERED ARE WHAT LEGISLATION HAS BEEN ADOPTED IN EACH COUNTRY THE DEVELOPMENT OF THE CASE LAW THAT EXISTS IN SOME STATES THE DEMOGRAPHIC IMPERATIVE EXISTING IN EACH COUNTRY MEASURES TAKEN TO IMPROVE THE POSITION OF YOUNG PEOPLE RETIREMENT AND THE EXIT FROM THE WORKFORCE OF OLDER WORKERS THE APPROACH AND CASE LAW OF THE EUROPEAN COURT OF JUSTICE AS AN IMPORTANT CONTRIBUTION TOWARDS AN UNDERSTANDING OF AGE DISCRIMINATION WITHIN THE EUROPEAN UNION THIS BOOK OPENS A FIELD OF LAW THAT HAS HERETOFORE NOT BEEN CONSIDERED IN ALL ITS SERIOUSNESS IT WILL BE OF REAL VALUE TO LAWYERS HUMAN RESOURCE MANAGEMENT PROFESSIONALS AND THOSE WITH AN INTEREST IN DISCRIMINATION AND EU ISSUES IT IS AN IMPORTANT CONTRIBUTION TO WHAT WILL BE A DEVELOPING FIELD OF STUDY

LEGAL CONSIDERATIONS
