Liabilities Current liabilities accounts payable shortterm debt are due within a year Non current liabilities longterm debt deferred taxes are due beyond a year

Equity This represents the residual interest in the assets after deducting liabilities It includes common stock retained earnings and other equity accounts

B The Income Statement

This statement shows a companys financial performance over a period eg a quarter or a year It outlines revenues expenses and the resulting net income or loss

Revenues The total income generated from sales and other operations

Expenses Costs incurred in generating revenues including cost of goods sold operating expenses interest expense and taxes

Net Income The bottom line the profit or loss after all expenses are deducted from 2 revenues

C The Statement of Cash Flows

This statement tracks the movement of cash both into and out of a company over a period It categorizes cash flows into operating investing and financing activities

Operating Activities Cash flows from the core business operations eg sales purchases salaries

Investing Activities Cash flows related to investments in longterm assets eg purchasing equipment selling securities

Financing Activities Cash flows related to financing the business eg issuing debt paying dividends repurchasing stock
