It proposes an alternative solution based on treating ordinary capital income in the same manner as capital gain with tax deferral until drawdown to achieve this. It relies on a novel combination of two taxes: the pre-paid and the post-paid consumption tax, whereby tax levied under the latter takes account of tax previously paid under the former. In other words, this Z-tax is a modified form of cash flow consumption tax where much of the tax is payable up front. It potentially allows all capital income to be treated similarly and allows excess returns/economic rents to be taxed.
