the book asserts that human security derives from the experience and expectation of human well being which depends on four essential conditions a life sustaining environment the meeting of essential physical needs respect for the identity and dignity of persons and groups protection from avoidable harm and expectations of remedy from them the book demonstrates their integral relationship to human security patriarchy being the germinal paradigm from which most major human institutions such as the state the economy organised religions and social relations have evolved the book argues that fundamental inequalities must be challenged for the sake of equality and security the fundamental point raised is that expectation of human well being is a continuing cause of armed conflict which constitutes a threat to peace and survival of all humanity and human security cannot exist within a militarised security system the editors of the book bring together 14 essays which critically examine militarised security in order to find human security pathways show ways in which to refute the dominant paradigm indicate a clear gender analysis that challenges the current system and suggests alternatives to militarised security with a mix of female and male feminist scholar activists as contributors the book makes an important contribution to a new discourse on human security

fifteen years after the adoption of un security council resolution 1325 which establishes the women peace and security agenda there is now a need to assess the impacts of gender equality efforts and to understand why and how gender equality reforms have advanced to the extent that they have this book examines how international peace and security is re envisioned from a gender perspective by mostly focusing on the nuances presented by the asia pacific region it argues that despite the diversity of political socio cultural and economic systems in the asia pacific women and girls in the region continue to experience similar forms of insecurities several countries in the asia pacific have demonstrated relative peace and stability in addition women s leadership and participation in peacebuilding are and continue to be increasingly recognized in the region too however as the chapters in this book demonstrate applying a critical gender analysis allows for the interrogation of veneers of political order which can then mask or normalise everyday gendered insecurities the analysis of country cases such as myanmar cambodia and fiji underscores a rethinking of the political order in the asia pacific which leaves existing

gender inequalities intact the chapters in this book were originally published in a special issue in the international feminist journal of politics

this book examines the relationship between women gender and the international security agenda exploring the meaning of security in terms of discourse and practice as well as the larger goals and strategies of the global women s movement today many complex global problems are being located within the security logic from the environment to hiv aids state and non state actors have made a practice out of securitizing issues that are not conventionally seen as such as most prominently demonstrated by the un security council resolution 1325 2001 activists for women s rights have increasingly framed women s rights and gender inequality as security issues in an attempt to gain access to the international security agenda particularly in the context of the united nations this book explores the nature and implications of the use of security language as a political framework for women tracing and analyzing the organizational dynamics of women s activism in the united nations system and how women have come to embrace and been impacted by the security framework globally and locally the book argues that from a feminist and human security perspective efforts to engender the security discourse have had both a broadening and limiting effect highlighting reasons to be sceptical of securitization as an inherently beneficial strategy four cases studies are used to develop the core themes 1 the campaign to implement un security council resolution 1325 2 the strategies utilized by those advocating women s issues in the security arena compared to those advocating for children 3 the organizational development of the un development fund for women and how it has come to securitize women and 4 the activity of the un peacebuilding commission and its challenges in gendering its security approach the work will be of interest to students of critical security gender studies international organizations and international relations in general natalie florea hudson received her phd in political science from the university of connecticut and is an assistant professor at the university of dayton she specializes in gender and international relations human rights international security studies and international law and organization

the united nations security council in 2000 unanimously passed a resolution calling for women s increased participation in conflict prevention and peacebuilding as well as their protection during conflict this marked the first time that the un security council explicitly addressed gender issues in conflict and post conflict situations but what difference has this international agenda on women peace and security made to women s lives on the ground and to the governance of international peace and security this volume provides a critical evaluation of the mainstreaming of gender issues in matters of international peace and security resulting from the passage of resolution 1325 in 2000 it considers how this agenda actually plays out in different contexts and with what implications for women s activism and for peace and security the picture that emerges is not uniform obliging us to reconsider the links between gender conflict different visions of peace and consequently different projects of peacebuilding consequently the book poses new questions for transnational feminist scholars and activists this book was based on a special issue of the international feminist journal of politics

how do understandings of the relationships between gender violence security and the international inform policy and practice in which these notions are central what are the practical implications of basing policy on problematic discourses in this highly original poststructural feminist critique the author maps the discursive terrains of institutions both ngos and the un which formulate and implement resolutions and guides of practice that affect gender issues in the context of international policy practices the author investigates un security council resolution 1325 passed in 2000 to address gender issues in conflict areas in order to examine the discursive construction of security policy that takes gender seriously in doing so she argues that language is not merely descriptive of social political reality but rather constitutive of it moving from concept to discourse and in turn to practice the author analyses the ways in which the resolution s discursive construction had an enormous influence over the practicalities of its implementation and how the resulting tensions and inconsistencies in its construction contributed to its failures the book argues for a re conceptualisation of gendered violence in conjunction with security in order to avoid partial and highly problematic understandings of their practical relationship drawing together theoretical work on discourses of gender violence and international security sexualised violence in war gender and peace processes and the domestic international dichotomy with her own rigorous empirical investigation the author develops a compelling discourse theoretical analysis that promises to have far reaching impact in both academic and policy environments

this volume explores the implementation of key gender policies in international peace and security following the adoption of un security council resolution 1325 in october 2000 the first thematic resolution on women peace and security how should we understand women s participation in peace processes and in peace operations and what forms of gendered security dynamics are present in armed conflict and international interventions these questions represent central themes of protection and participation that the international community has to address in order to implement unscr 1325 thus far the implementation has often employed varying approaches related to gender mainstreaming a third theme of the resolution yet there is a dearth of systematic data which until recently has restricted the ability of researchers to evaluate the progress in implementation and impact of unscr 1325 by engaging with both empirics and critical theory the authors of this edited volume make important contributions to the gender peace and security agenda they identify some of the problems of implementing unsc 1325 and offer a sobering assessment of progress of implementation and insights into how to advance our understanding through systematic research many of the chapters are focused on operational aspects of unscr 1325 but all also engage with the theoretical underpinnings of unscr 1325 to bring forth central debates on more fundamental challenges to the development of knowledge in the fields of gender peace and security this book will be of much interest to students of gender studies peace and conflict studies security studies and ir in general
