Problem 12 The primary market is where new securities are initially issued to investors For example when a company issues shares for the first time through an Initial Public Offering IPO its a primary market transaction The secondary market is where existing securities are bought and sold between investors Stock exchanges like the New York Stock Exchange NYSE and NASDAQ are examples of secondary markets
