declassified under the Japanese Imperial Government Disclosure Act federal agencies involved in the identification and declassification of relevant classified records ascertained that there were relatively few pertinent records that were still classified most relevant records were either never classified or were declassified decades before the act and were already in NARA's custody while this finding aid's coverage is broad it is not comprehensive researchers may find other relevant series of records within the record groups mentioned or not mentioned researchers are encouraged to use other finding aids and consult with NARA staff to locate records of interest in addition the National Archives at College Park holds non-textual records such as still photographs and motion pictures that researchers may want to examine other NARA facilities hold many records and donated material related to World War II including records related to the subjects covered in this finding aid this is particularly true of the Franklin D.
