historically viral outbreaks have affected farmed and wild shrimp stocks in the northwestern pacific coast of mexico *litopenaeus stylirostris* is one of the three main penaeid shrimp species in the region and represents a major component of the bulk of wild caught shrimp despite the economic importance of the species genetic diversity and population structure of *l. stylirostris* has been poorly studied and its interactions with viral pathogens remain unexplored in this study the genetic diversity population structure and demographic history of *l. stylirostris* populations were addressed using mitochondrial control region sequences the results showed that *l. stylirostris* have high levels of genetic diversity and their populations are geographically structured along the gulf of california factors

contributing to the observed population structure include historic geological events and contemporary physical oceanographic conditions the health status of *l stylirostris* populations was assessed by determining the prevalence of four of the main viral pathogens known to affect penaeid shrimp the results showed that infectious hypodermic haematopoietic necrosis virus ihhnv is highly prevalent across the geographic range while other viral pathogens are present in low levels or remained undetected based on these findings the population genetics rates of evolution and population history of ihhnv were studied using capsid region sequences the results showed that ihhnv has a high rate of nucleotide substitution comparable to rna viruses is more genetically diverse than previously reported and presents a significant subdivision among viral populations in the northwestern pacific coast of mexico this study provides important insights into the previously unexplored evolutionary and population dynamics of *l stylirostris* and ihhnv in the mexican northwestern pacific region
