a comprehensive introduction to public policy and the policy cycle the fully revised second edition of this popular textbook offers a practical guide to the topic while remaining underpinned by cutting edge research bringing together analysis of classic works alongside the most recent developments in the field this book is guided by the following three crucial questions what is public policy who participates in making and putting public policy in practice as well as in assessing its success and when and how does public policy change over time in answering these questions the book covers everything from the central institutions and actors of policy making to implementation evaluation and governance drawing on examples from across the world the new edition expands on themes that were previously covered only marginally including the underexplored connection between public policy and political economy as well as placing more emphasis on climate change and practical advice on doing policy analysis for undergraduate or postgraduate students studying on courses focussed on public policy or the policy cycle or process this textbook is the essential guide to the subject the book is also suited for those studying public policy in the context of politics or public management and

administration new to this edition a revised conclusion containing guidance on how to do policy analysis extended discussion of climate policy and politics consideration of the effects of brexit the rise of populism and the impact of the loss of faith in globalization for international organizations more on policy process theories comparative public policy the increasingly interdisciplinary nature of public policy studies and new methodologies such as the evaluation of policy measures by means of social media data

this ground breaking study offers a new paradigm for understanding the beliefs and religions of the goths burgundians sueves franks and lombards as they converted from paganism to christianity between c 350 and c 700 ce combining history and theology with approaches drawn from the cognitive science of religion belief and religion in barbarian europe uses both written and archaeological evidence to challenge many older ideas beginning with a re examination of our knowledge about the deities and rituals of their original religions it goes on to question the assumption that the germanic peoples were merely passive recipients of christian doctrine arguing that so called arianism was first developed as an entry level christianity for the goths focusing on individual ethnic groupings in turn it presents a fresh view of the relationship between religion and politics as their rulers attempted to opt for catholicism in place of familiar debates about post conversion pagan survivals contemporary texts and legislation are analysed to create an innovative cognitive perspective on the ways in which the church endeavoured to bring the christian god into people s thoughts and actions the work also includes a survey of a wide range of written and archaeological evidence contrasting traditional conceptions of death afterlife and funerary ritual with christian doctrine and practice in these areas and exploring some of the techniques developed by the church for assuaging popular anxieties about christian burial and the christian afterlife

examines the various forces and interests that influence and shape the regulatory endeavour and the practical challenges facing governments and regulators when deciding whether and how to regulate this volume is a study of regulation in context in the context of the public policy it is designed to deliver the law that enables shapes and holds it to account and the evolving societal and institutional frameworks within which it takes place aimed to provide innovative cross disciplinary conceptual frameworks that regulators regulatees those whom regulation is intended to benefit and academics might employ to better understand and undertake the regulatory endeavour this will be of great interest to researchers educators advanced students and practitioners working in the fields of political science public management and administration and public policy

western modernity is characterized by instrumental relations between humans and nature as well as between humans themselves that have caused irreversible environmental and social exploitation and degradation many policy documents such as those by the united nations environment programme warn of the uncertainty and unpredictability of our precarious conditions due to our social and ecological interrelations and interdependencies accepting that our position in the world does not allow us secure knowledge of the consequences of politics reversibility politics under conditions of uncertainty asks how we can act politically in a responsible way when we cannot predict the outcomes of our decisions hartmut behr diagnoses western modernity and its manifold crises as dominated by the view that fellow humans and natural environments are merely means to our individual ends behr introduces a novel ethics of self restraint and the principle of reversibility a commitment to political actions whose effects shall not be indefinite or immutable to build a policy framework that demands both ethical and practical reflection on the conditions of action and that accounts for the limitations under which

we act and live identifying an urgent need for re thinking political progress and for policy reform reversibility politics under conditions of uncertainty presents a new understanding of the self and of political responsibility centred in a genuine acknowledgment of the human condition

this book analyses the european court of justice s power from a political science perspective it argues that this power can be assessed through studying the policy implications of there being a supranational constitution that was drafted as an international treaty an international treaty contains a set of policy goals for future cooperation direct effect and supremacy give constitutional status to these policy goals allowing the court to develop the treaty s implications for policymaking at the european and the member state levels by focusing on the four freedoms of goods services persons and capital and citizenship rights the book analyses the implications of case law for policymaking in different case studies it shows how major eu legislation for instance the services and citizenship directives are significantly influenced by case law and how controversial policies such as eu citizens access to tax financed social benefits are closely linked to the court

constructing a policy making state sets out to examine the processes by which europeanization takes place europeanization is defined as the process by which the key decisions about public policies are gradually transferred to the european level or for new policy areas emerge at the european level this is in contrast to definitions of europeanization which focus on the adaption of member states to european public policies thus the main focus is whether a european union policy making state is being created via changes in the distribution of power between member states and the european level institutions over time in addition to several overview chapters such as on agenda setting in the eu there are twelve sectoral studies which analyse the differing

trajectories and outcomes of the europeanization process and the extent to which the european union can make authoritative allocations the case studies have been selected in order to illustrate the degree of cross sectoral variation in the process of europeanization from sectors which have yet to see very much europeanization such as health to sectors such as competition policy which are almost fully europeanized the book is consciously multi theoretic in its approach drawing on a range of theories and concepts from theories of european integration to theories of public policy processes

comparative politics provides a comprehensive introduction to political systems around the world it covers methods and theories the nation state institutions actors and processes policies and recent changes

influence of hard law on national policies still is a central topic in europeanisation research one aspect often overlooked is the impact of soft law instruments such as the open method of coordination omc through the omc all member states agree on common goals and exchange best practices to improve policy coordination in a certain area without the obligation how to design policies omc impacts in individual member states have been studied extensively yet a comparative perspective explaining their variance is lacking this study by niclas beinborn tries to fill this gap by analysing the different impacts of a recent omc the european youth strategy 2010 euys his analysis is twofold in a first step he applies theory driven fuzzy set qca to a novel dataset depicting the variance of national activities around the euys as causalities remain unclear in a second step he presents an innovative analysis framework encompassing two dimensions national motivation and relative openness to implement non binding eu law to define ideal types of omc adaptation case studies on the euys in germany and ireland proof the potential of this framework to explain why and how omcs work differently

the european union has developed a wide array of external relations with its neighbouring countries without offering full membership the eu nevertheless attempts to transfer its rules and policies to non member countries it is this extension of eu rules beyond eu borders that the analysis of external governance seeks to capture the contributions to this volume explain the modes and effects of eu external governance in a variety of eu non member country relations in western europe the former soviet union and the mediterranean region they cover such diverse issues as trade environment security and democracy promotion and explore the effects of eu institutions eu power and the domestic structures of its partner countries on the transfer of eu rules this book was based on a special issue of journal of european public policy

this volume of comparative studies documents the continuing relevance of the state in environmental politics and policy the book also demonstrates the analytical power of the comparative approach to the study of environmental politics and policy offering cross national comparisons of environmental governance in both developed and developing countries some

chapters are based on qualitative studies from a small number of countries others offer statistical analyses of quantitative data from many more countries over a longer time period

whereas some western democracies have turned toward substantially tougher law and order policies others have not how can we account for this discrepancy in the partisan politics of law and order georg wenzelburger argues that partisan politics have shaped the development of law and order policies in western countries over the past twenty five years wenzelburger establishes an integrated framework based on issue competition institutional context and policy feedback as the driving factors shaping penal policy using a large scale quantitative analysis of twenty western industrialized countries covering the period from 1995 to 2012 supplemented by case studies in the united kingdom germany france and sweden wenzelburger presents robust empirical evidence for the central role of political parties in law and order policy making by demonstrating how the configuration of party systems and institutional context affect law and order policies this book addresses an understudied but key dynamic in penal legislation the argument and evidence presented here will be of interest to political scientists sociologists criminologists and criminal justice scholars
