lizzie borden took an axe and gave her mother forty whacks when she saw what she had done she gave her father forty one lizzie andrew borden b 1860 d 1927 was tried and acquitted in the 1892 axe murders of her father and stepmother in fall river massachusetts media coverage of the case created a furor throughout the united states reminiscent of the rosenberg claus von bulow and o j simpson trials no other suspect was ever charged with the double homicide and speculation on the case continues to this day the case is curious because there was no physical evidence linking lizzie to the murder the broken axe the police found in the basement was clean of blood and the police refused to use forensic testing for fingerprints a science then in its infancy the defense raised

lizzie andrew borden was born july 19 1860 and was an american woman who gained infamy in being tried and

acquitted for the 1892 axe murders of her father and stepmother in fall river massachusetts the case was a cause célèbre throughout the united states following her release from the prison in which she had been held during the trial borden chose to remain a resident of fall river massachusetts for the rest of her life despite facing significant ostracism the commonwealth of massachusetts elected to charge no one else with the murder of andrew and abby borden speculation about the crimes still continues more than 100 years later
