common law it is applicable to all the states of india except the state of jammu and kashmir it determines the circumstances in which promises made by the parties to a contract shall be legally binding on them all of us enter into a number of contracts everyday knowingly or unknowingly each contract creates some rights and duties on the contracting parties hence this legislation indian contract act of 1872 being of skeletal nature deals with the enforcement of these rights and duties on the parties in india it was enacted mainly with a view to ensure reasonable fulfillment of expectation created by the promises of the parties and also enforcement of obligations prescribed by an agreement between the parties the third law commission of british india formed in 1861 under the stewardship of chairman sir john romilly with initial members as sir edward ryan r lowe j m macleod sir w erle succeeded by sir w m james and justice wills succeeded by j henderson had presented the report on contract law for india as draft contract law 1866 the draft law was enacted as the act 9 of 1872 on 25 april 1872 and the indian contract act 1872 came into force with effect from 1 september 1872 before the enactment of the indian contract act 1872 there was no codified law governing contracts in india in the presidency towns of madras bombay and calcutta law relating to contract was dealt with the charter granted in 1726 by king george i to the east india company thereafter in 1781 in the presidency towns act of settlement passed by the british government came into force act of settlement required the supreme court of india that questions of inheritance and succession and all matters of contract and dealing between party and party should be determined in case of hindu as per hindu law and in case of muslim as per muslim law and when parties to a suit belonged to different persuasions then the law of the defendant was to apply in outside presidency towns matters with regard to contract was mainly dealt with through english contract laws the principle of justice equity and good conscience was followed
