responding to a diplomatic stalemate and a catastrophic humanitarian crisis yemen s civil actors work every day to build peace in fragmented local communities across the country this book shows how their efforts relate to longstanding justice demands in yemeni society and details three decades of alternating elite indifference toward or strategic engagement with questions of justice exploring the transformative impact of the 2011 uprising and yemenis substantive wrestling with questions of justice in the years that followed leading yemen scholar stacey philbrick yadav shows how the transitional process was ultimately overtaken by war and explains why features of the

transitional framework nevertheless remain a central reference point for civil actors engaged in peacebuilding today in the absence of a negotiated settlement everyday peacebuilding has become a new site for justice work as an arena in which civil actors enjoy agency and social recognition drawing on seventeen years of field research and interviews with civil actors yadav positions yemen s non combatants not or not only as victims of conflict but as political agents imagining and enacting the justice they wish to see

the transition process in yemen since the arab spring has defied expectations the country moved from the brink of civil war to a managed transition process under international mediation that has largely remained on track despite repeated setbacks and delays what has enabled this is a combination of a domestic balance of weakness and concerted international mediation efforts yemen s multipolarity however threatens to undo the achievements made and tear the country apart because major challenges from a dismal security and humanitarian situation to questions of statehood remain unresolved

this international relations study investigates the underlying causes of the yemen crisis by analyzing the interactions of global regional and local actors at all phases gcc member states played a key role from political negotiations amidst street protests in 2011 to formation of an international military coalition in 2015 using a multi actor model the book shows that various actors whether state or non state foreign or domestic combined to create a disastrous armed conflict and humanitarian crisis yemen s tragedy is often blamed on saudi arabia and its rivalry with iran which is usually defined in sectarian sunni shia terms yet the book presents a more complex picture of what happened due to involvement by many other foreign actors such as the uae un uk us eu russia china turkey oman qatar and african states of the red sea and horn of africa

the dramatic uprisings that ousted the long standing leaders of several countries in the arab region set in motion an unprecedented period of social political and legal transformation the prosecution of political leaders took centre stage in the pursuit of transitional justice following the arab spring through a comparative case study of egypt libya tunisia and yemen this book argues that transitional justice in the arab region presents the strongest challenge yet to the transitional justice paradigm this paradigm is built on the underlying assumption that transitions constitute a shift from non liberal to liberal democratic regimes where often legal measures are taken to address atrocities committed during the prior regime the book is guided by two principal questions first what trigger and driving factors led to the decision of whether or not to prosecute former political leaders and second what shaping factors affected the content and extent of decisions regarding prosecution in answering these questions the book enhances our understanding of how transitional justice is pursued by different actors in varied contexts in doing so it challenges the predominant understanding that transitional justice uniformly occurs in liberalising contexts and calls for a re thinking of transitional justice theory and practice using original findings generated from almost 50 interviews across 4 countries this research builds on the growing critical literature that claims that transitional justice is an under theorised field and needs to be developed to take into account non liberal and complex transitions it will be stimulating and thought provoking

have arab uprisings opened space for deeper grassroots driven decentralization reforms in the region what are the optimum designs sequencing and models of decentralization for countries in political transition while political discourse in the region uniformly emphasizes reforming state institutions decentralization reform agendas have unfolded along contrasting trajectories across arab transition countries both contextual and historical dynamics seem to shape visions for the orientation and pace of decentralization reforms as well as the empirical feasibility of shifting power relations among the various tiers of state administration drawing on findings from field research and recent analyses this study argues that uprisings have created stronger momentum for revisiting the question of decentralization reforms in libya and yemen where the very nature of the state is being redefined compared to the cases of egypt and tunisia where all stakeholders agree on preserving the unitary state model in the latter cases while there is evidence that new advocacy movements focused on reforming local government structures have emerged they have thus far remained elite led grassroots activism at local community levels has served to empower new actors who in some cases have been successful at extracting concessions from local authorities these efforts however predominantly focus on improving access to public services within the existing context of centralized state structures and seem often to have failed to gain the trust of local community members as potential partners in local governance building on focus group discussions among working class residents in greater cairo and on interviews with egyptian political elites the study highlights an emerging critical gap between youth expectations and on the other hand the envisioned plans of the political elite while youth are more likely to demand deeper reforms across all three dimensions of decentralization administrative fiscal and political political elites disagree not only on which particular dimensions of reforms should be implemented but also on the urgency of decentralization during early phases of political transformation the latter s wide range of views reflect deep concerns over political capture by traditional elites weakness of political parties as well as potentially detrimental impacts of reforms on state capacity and the nation state s territorial integrity the study concludes by drawing lessons from france s successful contract based record of decentralization and presents policy recommendations for countries that have emerged from the arab uprisings with relatively strong centralized state structures and cohesive national identities publisher s description
